## LICENSE DECLARATION FOR COURT VALIDATED MARKS

### Representation, Warranty and Acknowledgement:

#### By signing and submitting this License Declaration, Licensor and Licensee represent, warrant and acknowledge that:

1. They have, prior to submitting their Trademarks Records entered into a license arrangement concerning the use of the above Marks and Domain Name Labels. This license arrangement allows the Licensee, or if applicable, the trademark agent designated by the Licensee, to:

1.
